* The award of stag-2 to Dr. Bhagwan Singh Shekhawat is recommended subject to fulfillment of following conditions levied by the Selection Committee in its recommendations:-

1. श्री भगवानसिंह शेखावत, सहायक आचार्य, इतिहास विभाग द्वारा अभी तक पीएचडी की डिग्री हासिल नहीं की है और नियमानुसार उनके द्वारा एमफिल की डिग्री प्राप्त होने पर 5 वर्ष के सेवा पूर्ण करने पर यदि इनकी पूर्व का सेवाकाल, जो कि इन्होंने राजकीय महाविद्यालय में प्रदान की है, को विश्वविद्यालय प्रशासन द्वारा स्वीकार कर इनके सेवाकाल में जोड़ जी जाती है तो इन्हे नियमानुसार अपनी सेवा के पांच वर्ष पूर्ण होने की तिथि से स्टेज प्रथम से स्टेज द्वितीय का परिलाभ दिया जाये।


2. श्री भगवानसिंह शेखावत ने फरवरी 2013 में इस विश्वविद्यालय में सहायक आचार्य, इतिहास में कार्यभार ग्रहण किया है लेकिन अभी तक इनकी विश्वविद्यालय सेवा का स्थायीकरण नहीं हुआ है।

उपरोक्त दोनों शर्तें पूर्ण होने पर श्री भगवानसिंह शेखावत को नियमानुसार अपनी सेवा के पांच वर्ष पूर्ण होने पर स्टेज प्रथम से स्टेज द्वितीय में पदोन्नति दी जा सकती है।

It was further RESOLVED that for compliance of the directions of the Hon'ble High Court dated 19.12.2016 (part C) and in view of the direction of the State Government vide No. P. 6 (4) Edu-4/2010 dated 14.01.2016, the actual benefit shall be given to the incumbent for promotion under CAS only w.e.f. the date of recommendations of the Selection Committee approved by the Syndicate i.e. w.e.f. 01.03.2020 and the period from the date of Eligibility to 29.02.2020 shall be treated as notional.

The said promotion will be subject to the final outcome of various Writ Petitions filed for challenging the recruitment process of 2013 and directions, instruction and orders of the Hon'ble Governor Secretariat and State Government.
